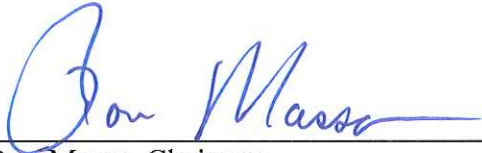
**Commissioner Kotrady moved to approve Consent Agenda. Commissioner Point seconded the motion, and by a vote of 7-0 the motion carried unanimously.**

**REGULAR AGENDA**

- 4) Zoning Change: The Laws Addition No. 2.** Consider a request from Robert C. Laws., the owner of properties described as 212 Far Vela Lane, 2105 Ranch Road 620 South and 2109 Ranch Road 620 South, for a zoning change from R-1 Temp (Single-Family Residential-Temporary) to R-6 (Single-Family Residential -Rural), C-1 (Office/Retail), C-2 (Commercial/Light Industrial), and GB (Greenbelt) for the subject properties.
- Staff report by Chessie Zimmerman. Staff recommended approval.
  - No presentation was made by the applicant
  - Citizen participation/public hearing – Kevin Williams of 206 Far Vela, Herman Ortega of 107 Far Vela, and Patrick Mullins of 210 Far Vela expressed concerns about the R-6 zoning classification.
  - Commission discussion/action – **After discussion, Commissioner Point made a motion to recommend to City Council the proposed zoning change as requested, but excluding uses 5A, 5C, and 5D from the R-6 area, and limiting the 5B usage to areas behind(north) of the home. The motion was seconded by Commissioner Trecker, and by a vote of 6-1, the motion passed. Commissioner Bertram was the only “nay” vote.**
